I understand there is a risk of personal injury and property damage. Further, I understand that the responsibility for a boat's decision to participate in a race or to continue racing is hers alone. I acknowledge and agree that we (myself and my guests and crew) are participating in this race, event or series entirely at our own risk and of our own desire and that we alone are responsible for our decision to participate in any given event or race.

In consideration of being permitted to enter sailboat races sponsored by the St. Joseph River Yacht Club, Saint Joseph, Michigan, and being fully knowledgeable of the risks of sailing as a competitive sport, the undersigned voluntarily assumes the total risk of participating in said races. Further, the undersigned hereby releases and forever discharges the Saint Joseph River Yacht Club, its officers, directors, race committee, and members from any and all actions, causes of actions, claims and demands for damages, loss or injury, howsoever arising, which may be sustained now or in the future as a result of participating in races sponsored by the aforementioned club.

The owner of each boat shall be fully responsible for the actions and safety of his/her crew and hereby accepts any liability resulting from such actions and responsibility for such safety regardless of whether the owner is aboard the boat. It shall be the responsibility of the owner to advise his/her skipper or crew of the content of this agreement. It shall be the sole responsibility of each owner or skipper to decide whether to start or continue a race.

Further, the Owner is strongly advised to purchase adequate insurance to cover the potential liability inherent in sailboat racing and the terms of this waiver. Finally, Owner agrees to follow all precautions regarding protection from Covid 19 in accordance with rule and announcements from federal, state and local governmental agencies while engaged in racing events.
